## Data Extraction

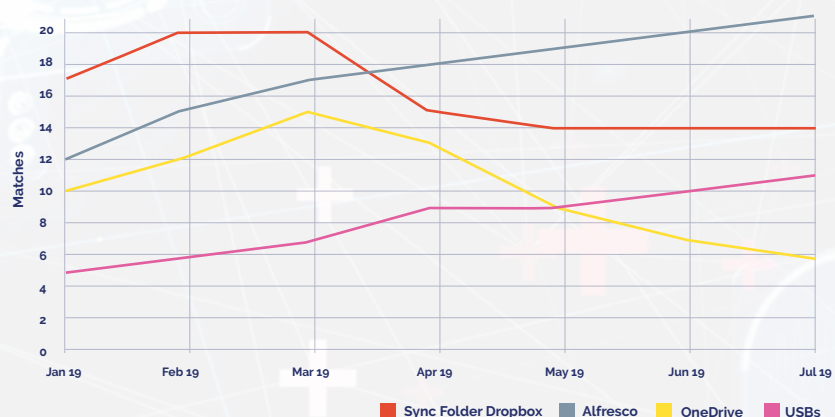

Where Sensitive Data has been found > Key risk areas





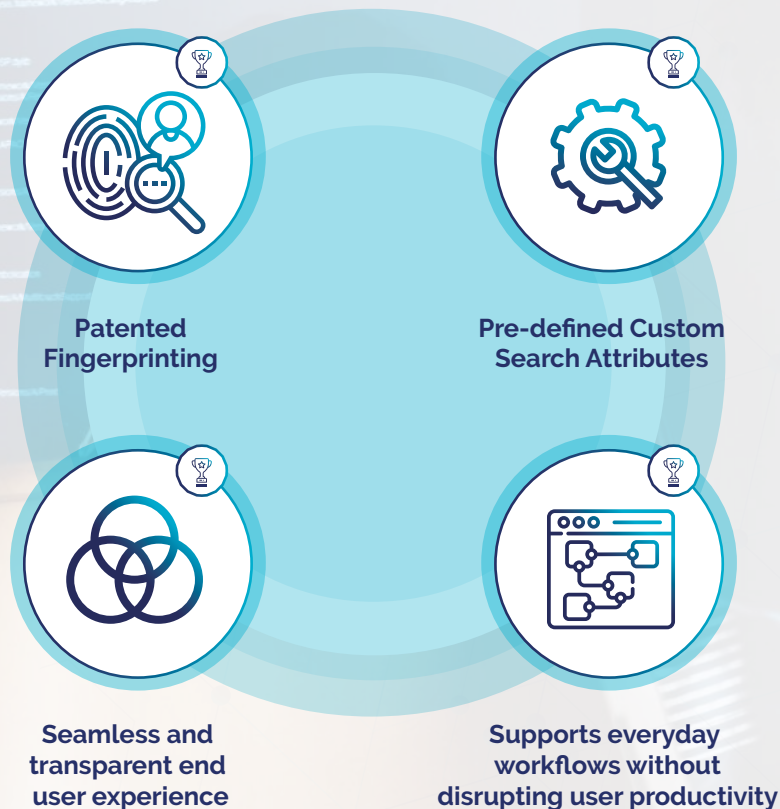

## Locate data for regulatory compliance

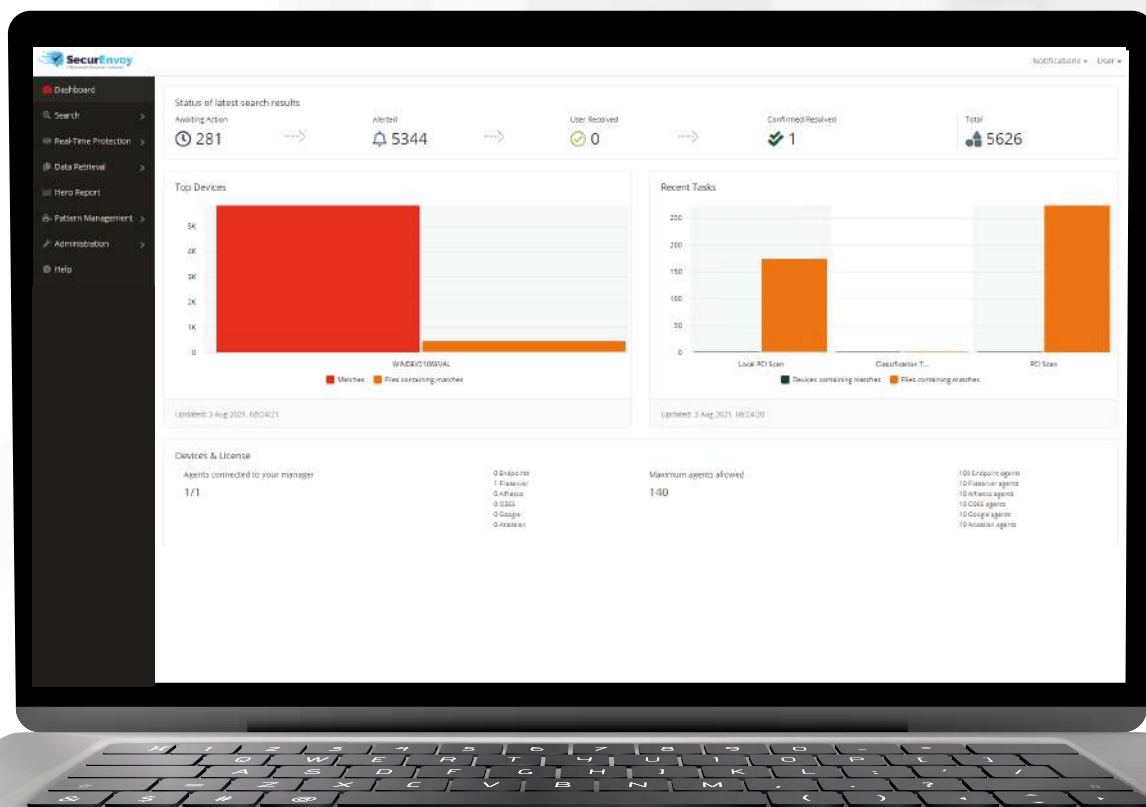
There are two components that make up the Data Discovery element:

## ✓ Endpoint Manager

A user interface to manage search tasks, devices, users, licenses and other areas of SecurEnvoy Data Discovery.

## ✓ Endpoint Agent

Installed on each of the monitored endpoints. Available for Windows, Mac and Linux. Windows agents can also be deployed on Windows Server 2012+ and .msi files can be deployed using systems such as GPO and SCCM.
